



**UTAH NON-RESIDENT TUITION EXEMPTION REQUEST**  
**Utah Code § 53B-8-106 (HB144)**  
**For Eligible Utah High School Graduates**

**GENERAL INFORMATION**

Any student other than a non-immigrant alien who meets all the following requirements, shall be exempt from paying the non-resident portion of the total tuition at Utah Tech University. Student information provided in this affidavit is strictly confidential unless disclosure is required by law.

**REQUIREMENTS**

- The student must have attended a Utah high school for three or more years.
- The student must have graduated from a Utah high school or attained the equivalent of a high school diploma.
- The student cannot have registered at a Utah System of Higher Education institution earlier than Fall of 2002.
- Students must submit their official high school transcript(s) validating three-year high school attendance in Utah and graduation from a Utah high school.
- A student, who is without lawful immigration status, must file an affidavit with Utah Tech University stating that he or she has filed an application to legalize immigration status, or will file an application as soon as he or she is eligible to do so.
- Students who hold a non-immigrant visa are not eligible for this exemption.
- The student must file a signed affidavit with Utah Tech University that indicates they have met all applicable conditions described above.
- Students eligible for this exemption who are transferring to another Utah public college or university must submit a new request (and documentation if required) to each college under consideration.
- Students meeting the criteria will have the non-resident portion of their tuition waived, but continue to be classified as non-residents.
- Students who qualify for the non-resident tuition exemption are not eligible for state and federal financial aid.

**PROCEDURES FOR REQUESTING A UTAH NON-RESIDENT TUITION EXEMPTION AT UTAH TECH UNIVERSITY:**

1. Fill out and sign the Utah Tech University Affidavit for non-resident tuition exemption on the reverse side of this form and turn it in to the Registrar's Office on the first floor of the Holland Centennial Commons.
2. In addition to any credentials necessary for admissions to Utah Tech University, you must arrange to have your final Utah high school transcript verifying graduation sent directly to the Utah Tech University Registrar's Office. The transcript must show completion of at least three years in a Utah high school and proof that you have graduated from the Utah high school or have an equivalent of a high school diploma in Utah.

Complete and sign this form to request a non-resident tuition exemption. Once you are determined to be eligible for the exemption, you will continue to receive it as long as you fulfill the requirements listed below or Utah Tech University no longer offers this exemption. Applying for the exemption does not in any way alter your responsibility to pay on time any non-resident tuition and associated fees that may be due before your eligibility is determined. In order to be considered for the current semester, this affidavit and supporting credentials must be received at the Registrar's Office by the first week of the semester.

**APPLICATION**

I, the undersigned, am applying for a Utah Tech University tuition exemption for eligible Utah high school graduates and declare that ALL of the following apply to me (select YES or NO )
