Physical Therapist Assistant, AAS

Program Description

A physical therapist assistant (PTA) is licensed to practice physical therapy under the supervision of a physical therapist (PT). This is one of two entry points into the field of physical therapy. PTA's treat people who are recovering from injuries to the bones and joints, brain and nerves, problems with pain, developmental complications, and movement disorders. Their main purpose is to assist people with reaching their optimal level of health and function. They help people to recover their ability to walk, heal from wounds, and overcome the effects of injuries and other health problems. Physical therapists (PTs) are responsible for evaluating and treating people who need physical therapy services. They identify problems that physical therapy can address, create goals, and decide what treatment the person will receive. PTA's work anywhere that physical therapists work, including hospitals, rehabilitation centers, outpatient clinics, skilled nursing facilities, schools, and home health. Specialty areas in physical therapy include orthopedics, neurology, pelvic health, vestibular, and more. PTA's work exclusively under the direction of physical therapists – this is required by professional ethics, codes of conduct, and by law.

Licensure

Utah Tech Physical Therapist Assistant program graduates are eligible to sit for the National Physical Therapy Exam (NPTE), a required step toward receiving a physical therapist assistant license. The NPTE is administered through the Federation of State Boards of Physical Therapy (FSBPT), whose mission is to protect the public by providing service and leadership that promote safe and competent physical therapy practice.

Professional Licensure/Certification (PLC) Requirements

The curriculum for programs at Utah Tech University leading to professional licensure are designed to prepare students for Utah licensure and certification requirements. Admission into programs for professions requiring licensure and certification does not guarantee that students will obtain a license or certificate. Licensure and certification requirements are set by agencies that are not controlled by or affiliated with the University, and licensure and certification requirements can change at any time.

Licensure boards in each state establish requirements for licensure and certification for their respective state. States vary by which professions are required to be licensed and how licensure functions, and such requirements may change at any time. The terms related to licensure and certification, among others, also vary by state as well.

Students and prospective students are strongly encouraged to contact the state licensure entity in the state where they intend to work to review all licensure and certification requirements imposed by the student's state(s) of choice. The University cannot provide verification of a student's ability to meet licensure or certification requirements unrelated to its educational programming. Some states require individuals to complete additional requirements that are unrelated to educational prerequisites.
