2022-2023 Tuition & Fees

Full-time 2022-23 undergraduate resident students at Utah Tech University paying a semester tuition and fee amount of \$3,037 (before any financial aid, scholarships, or waivers) contribute an estimated 51 percent to the full cost of instruction per full-time student of \$5,949. The remaining support for the full cost of instruction is provided by \$2,911 of state tax funds.
